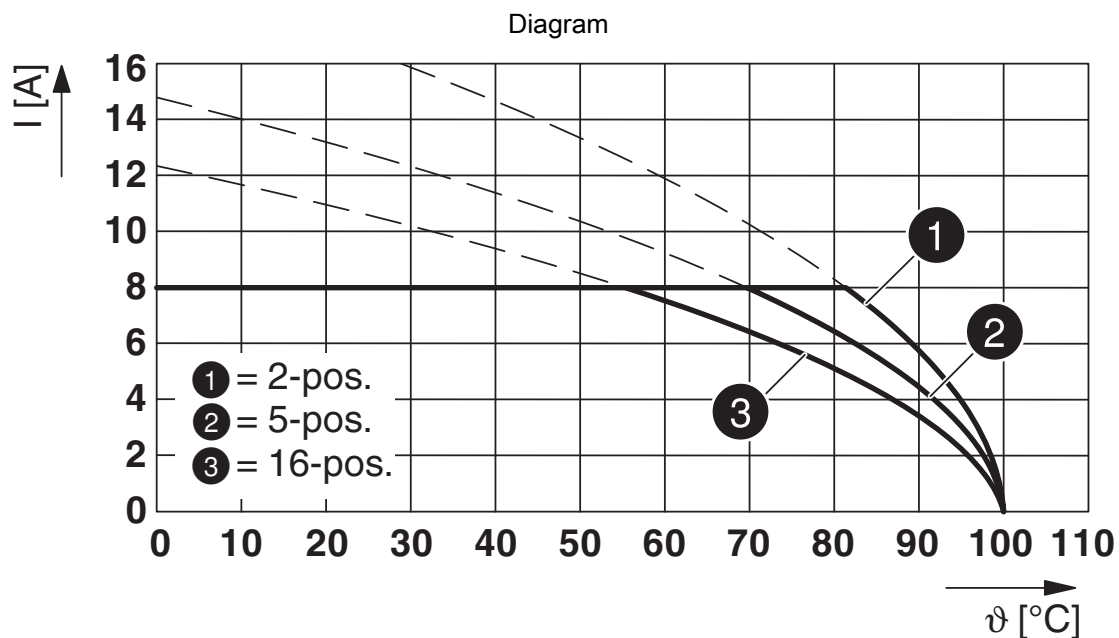


Type: FMC 1,5/...-STF-3,81 with MCV 1,5/...-GF-3,81 P... THR

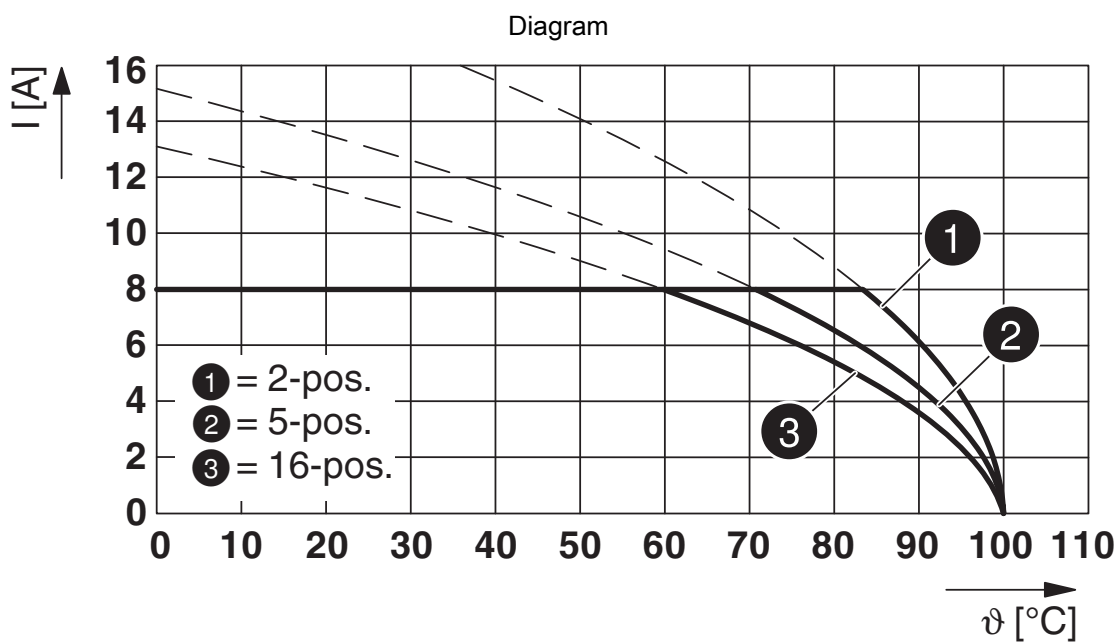

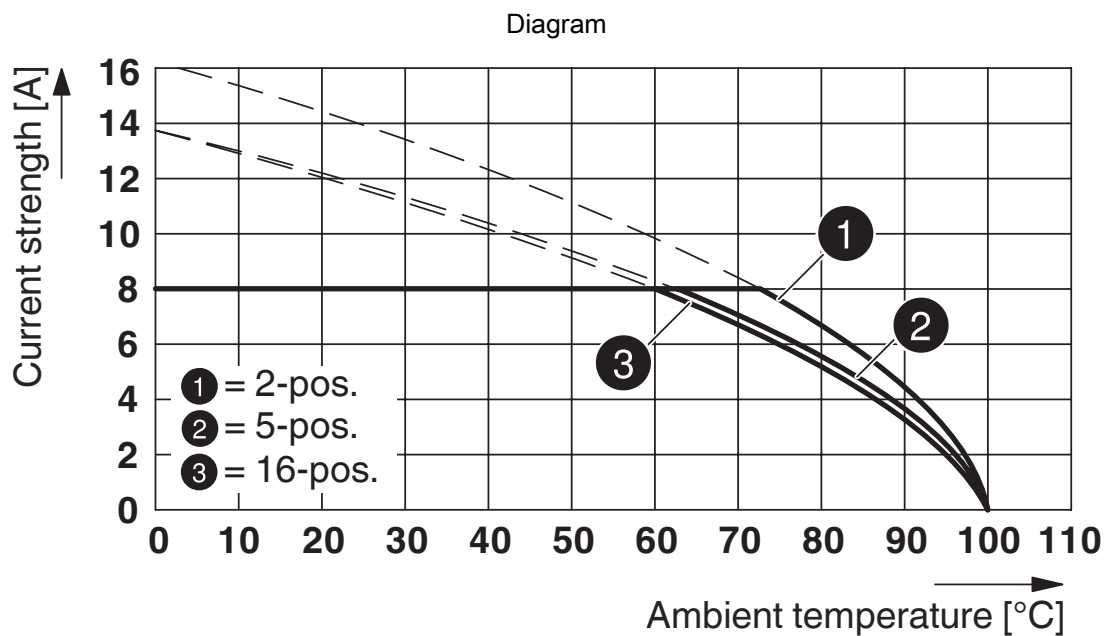

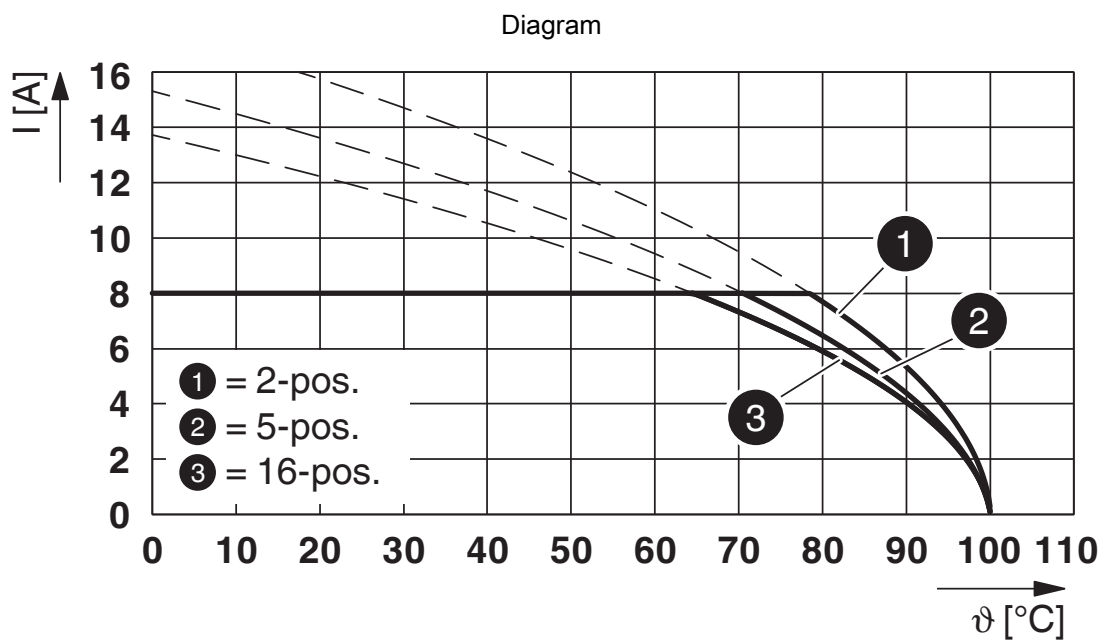
Type: FMC 1,5/...-STF-3,81 with MCD 1,5/...-G1F-3,81



Type: FMC 1,5/...-STF-3,81 with MCDV 1,5/...-GF-3,81

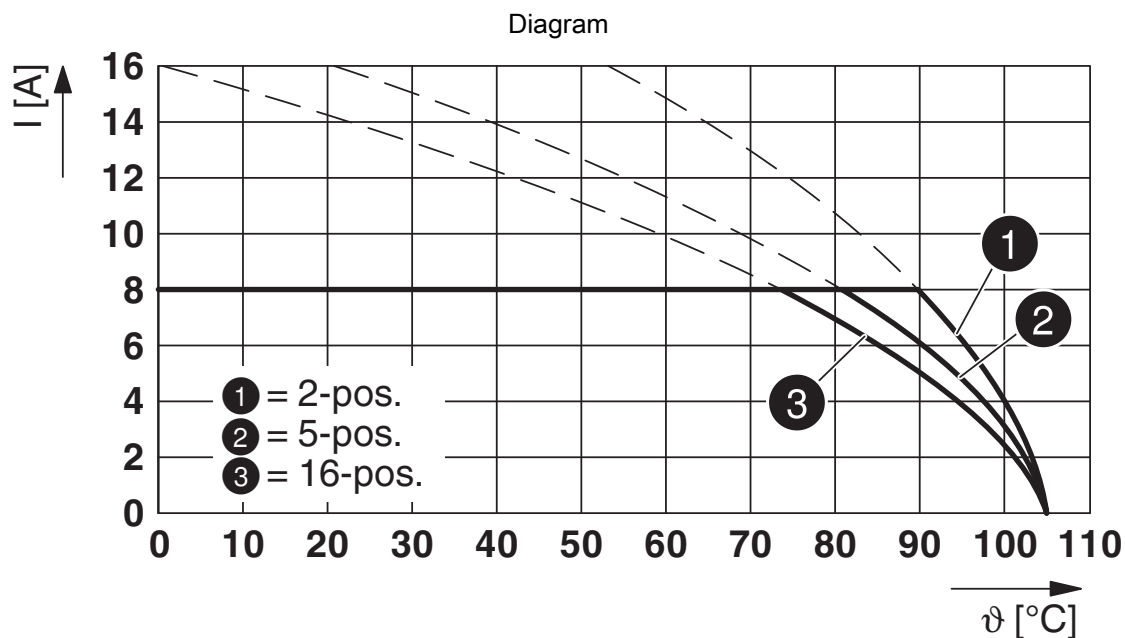


Type: FMC 1,5/...-STF-3,81 with DFK-MC 1,5/...-GF-3,81

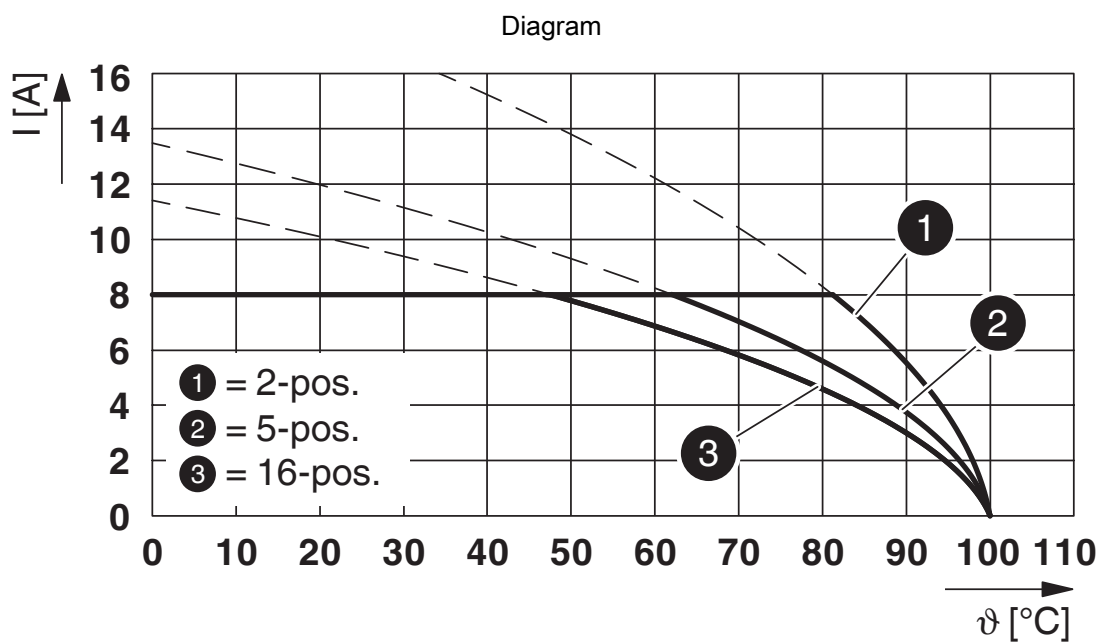
