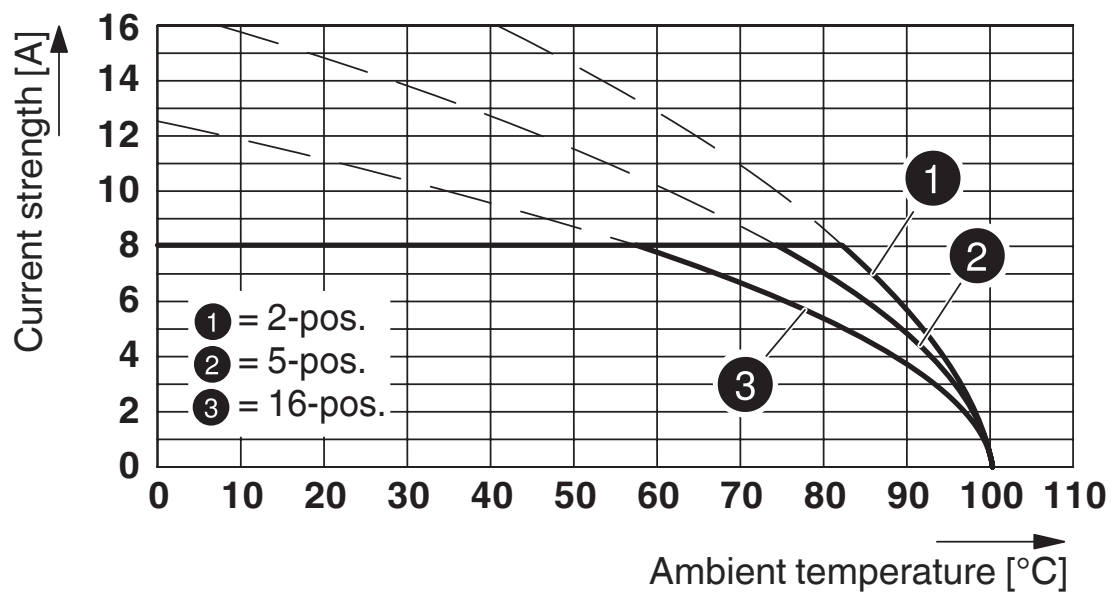

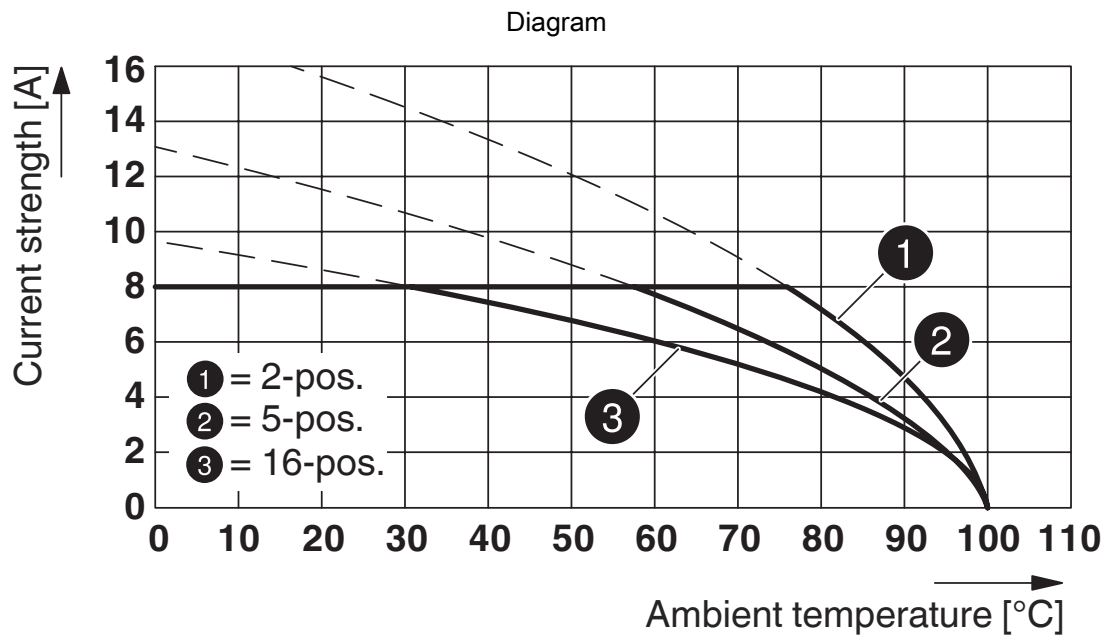

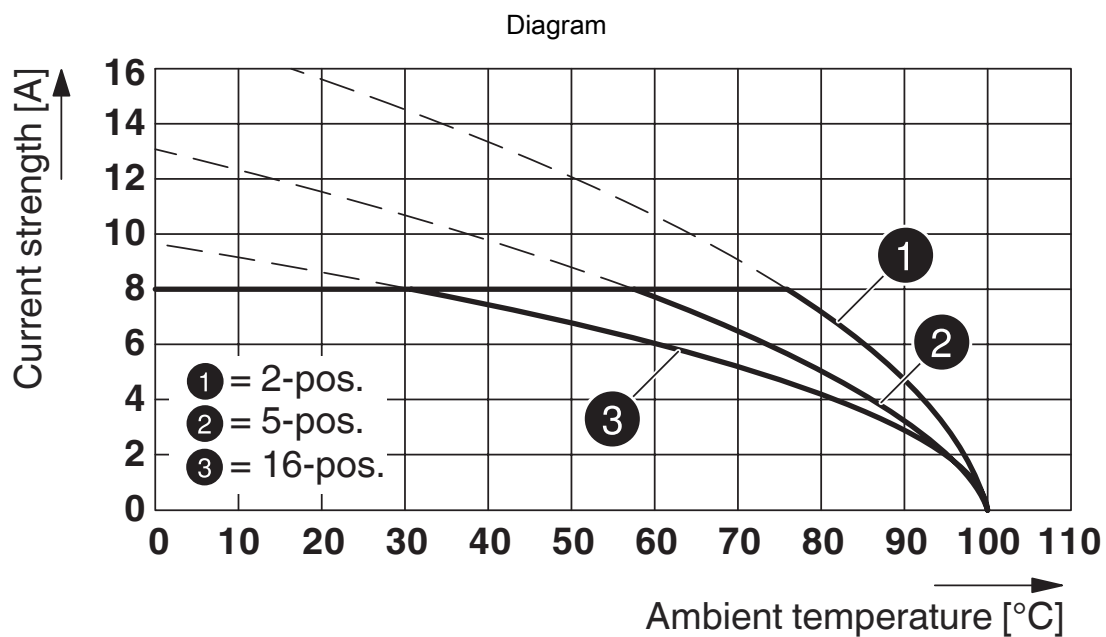

Type: MCV(W/R) 1,5/...-ST-3,81 with MCD 1,5/...-G1-3,81



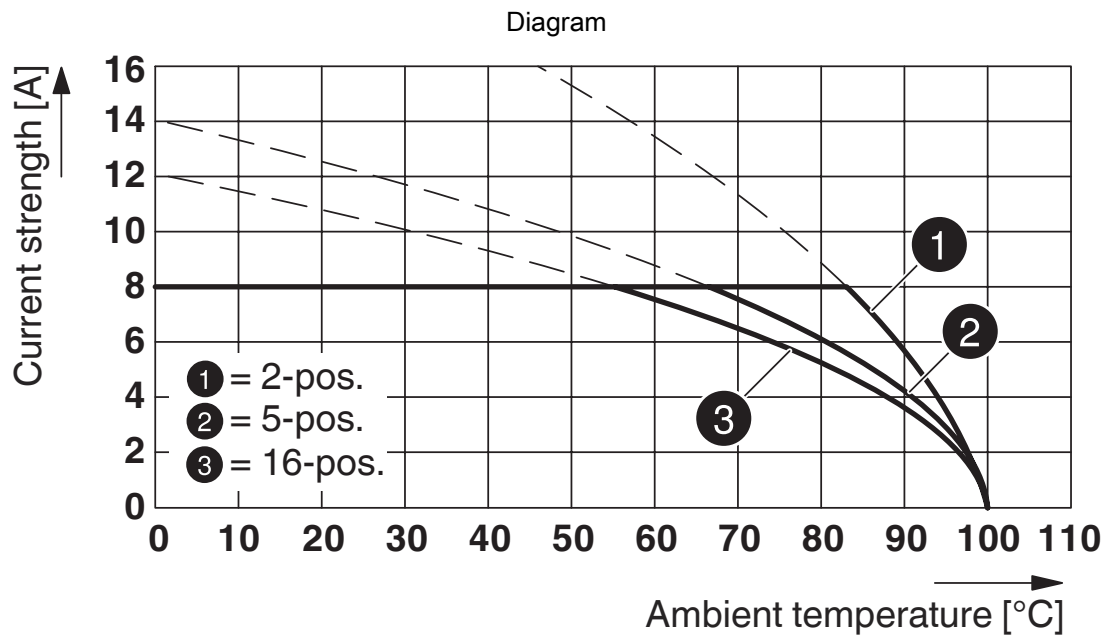

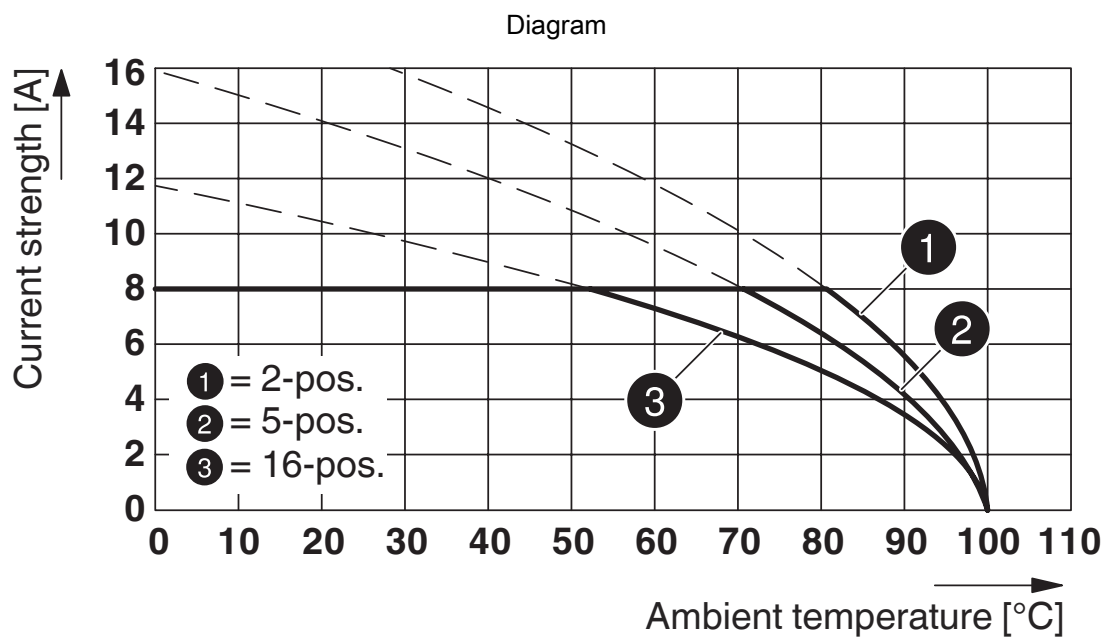

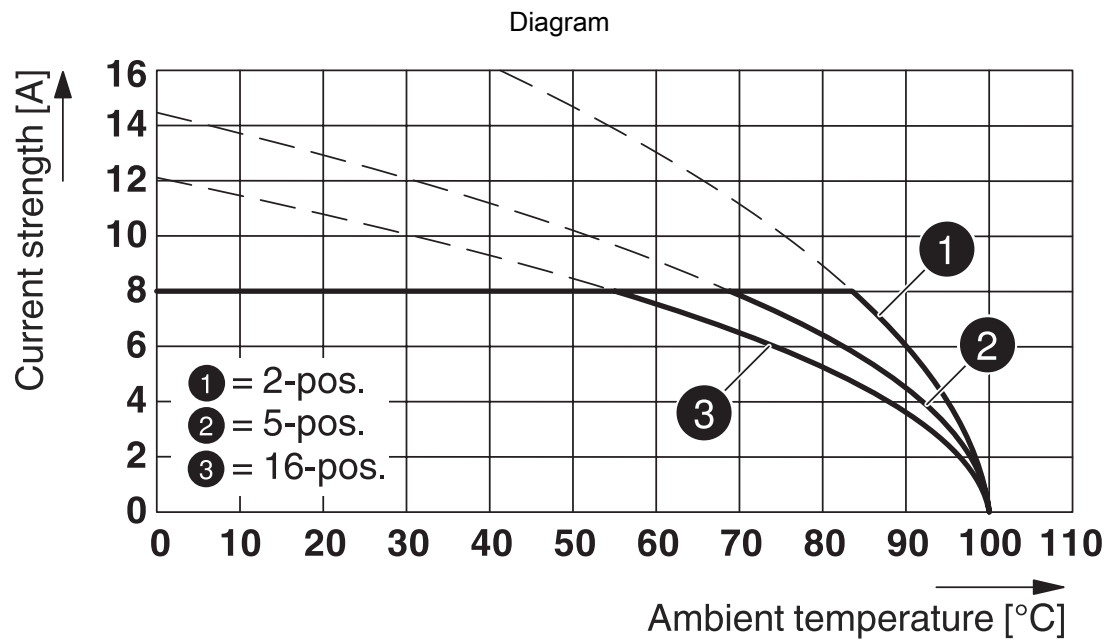

Type: FRONT-MC 1,5/...-ST-3,81 with MCD 1,5/...-G1-3,81

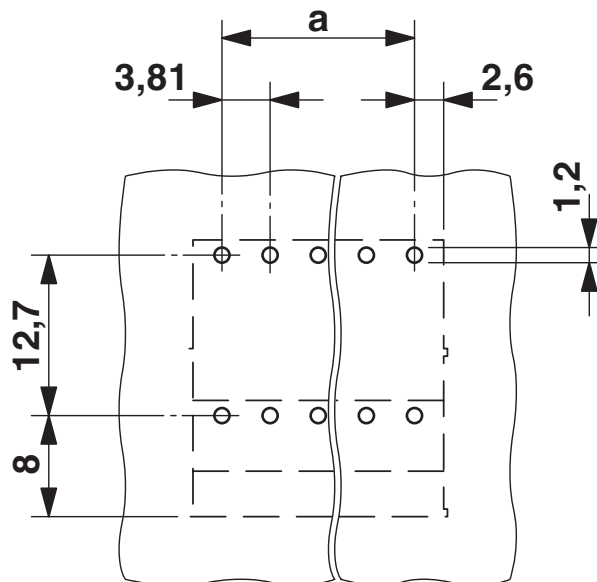


Type: FK-MCP 1,5/...-ST-3,81 with MCD 1,5/...-G1-3,81
