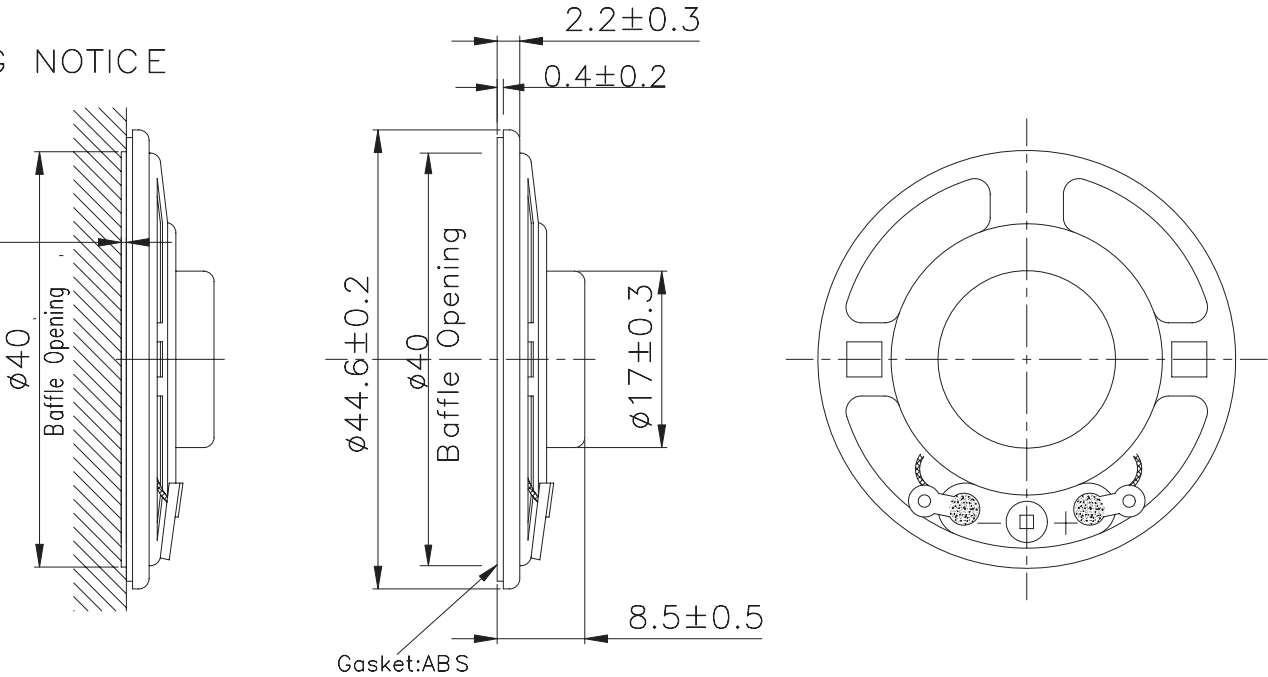

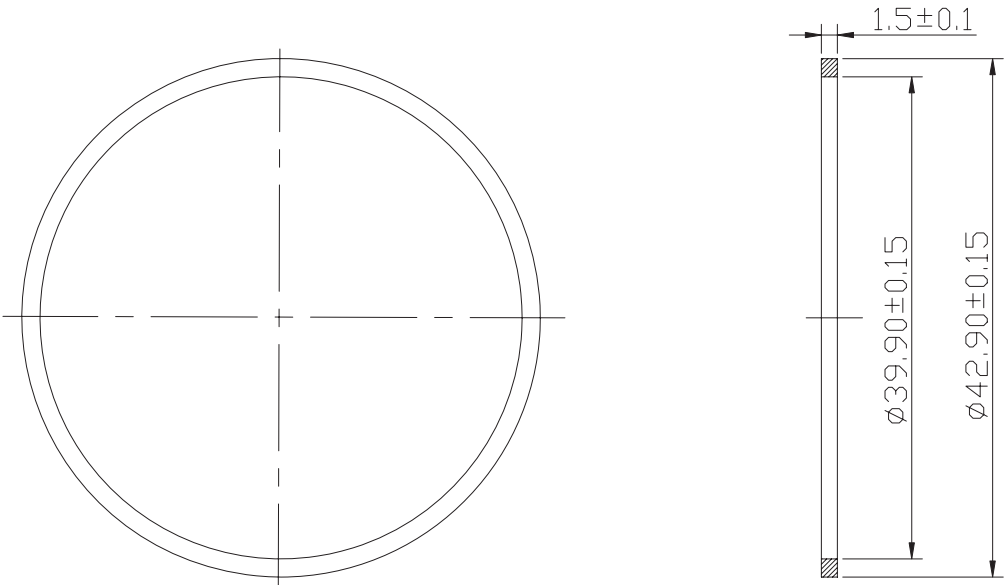

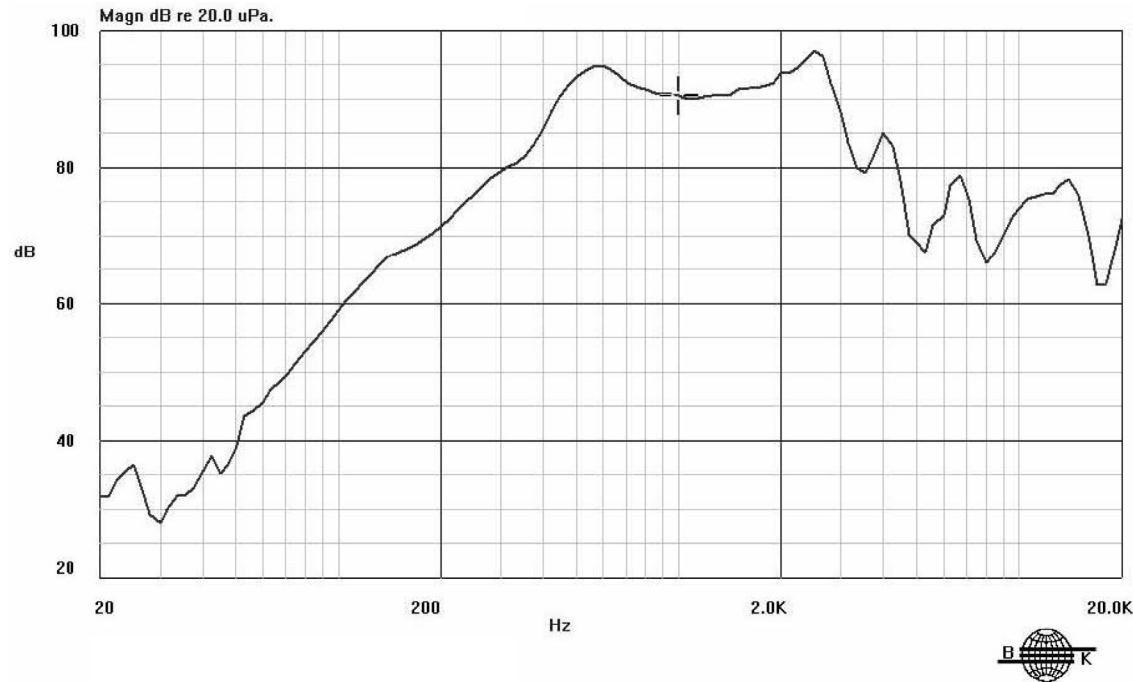
GASKET
