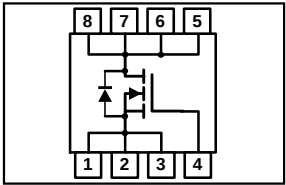

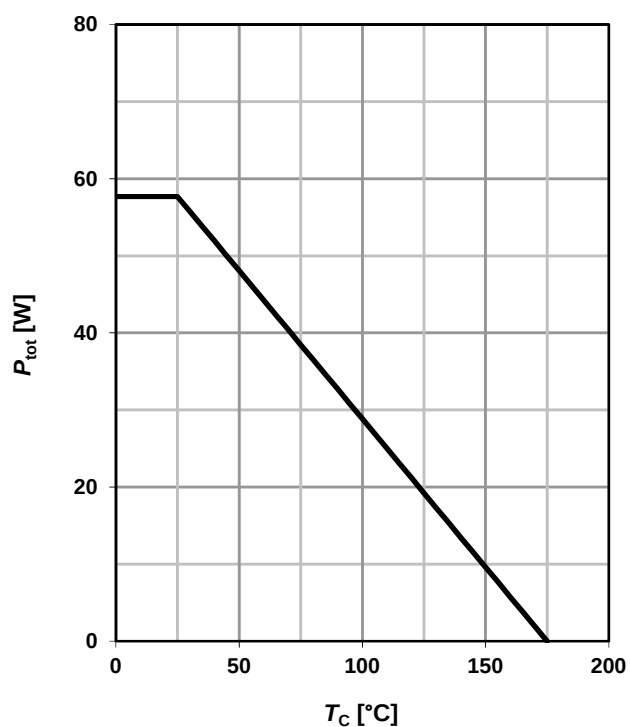

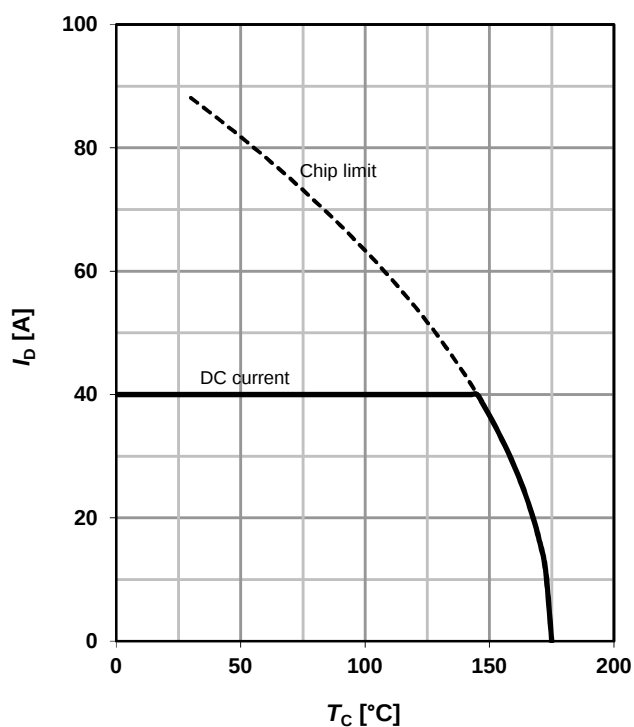
1 Power dissipation

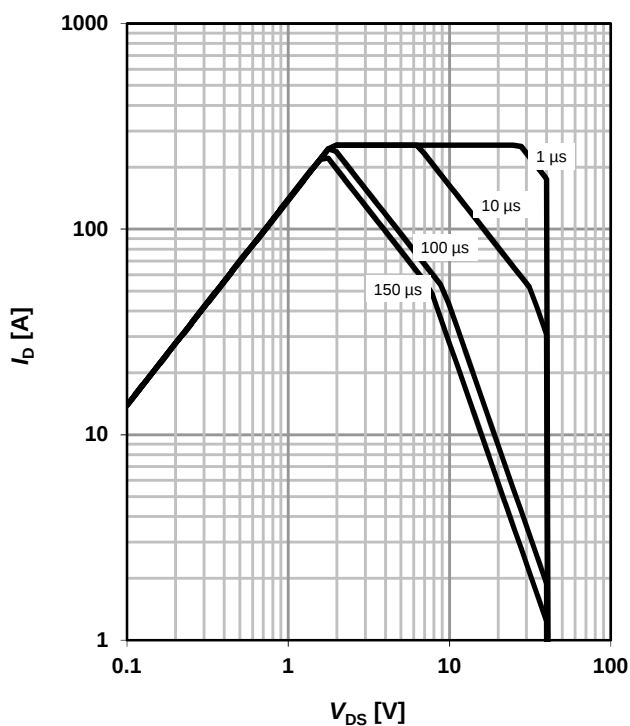
2 Drain current

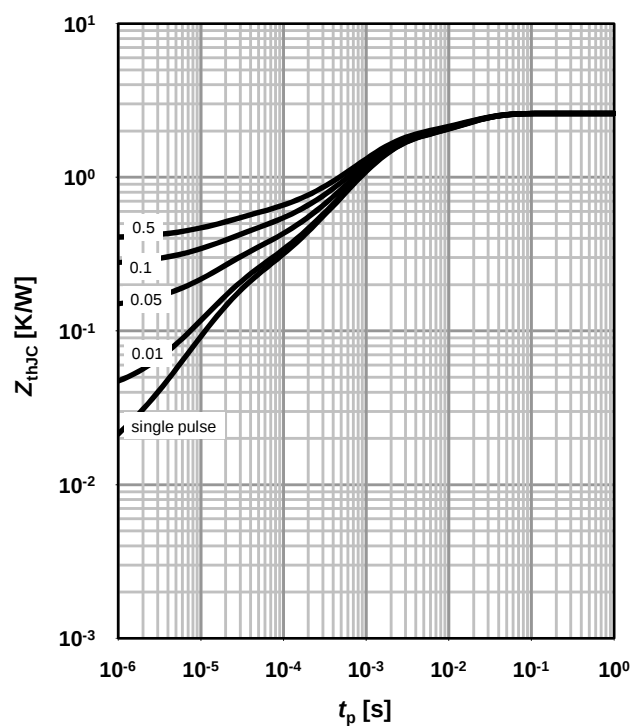
3 Safe operating area

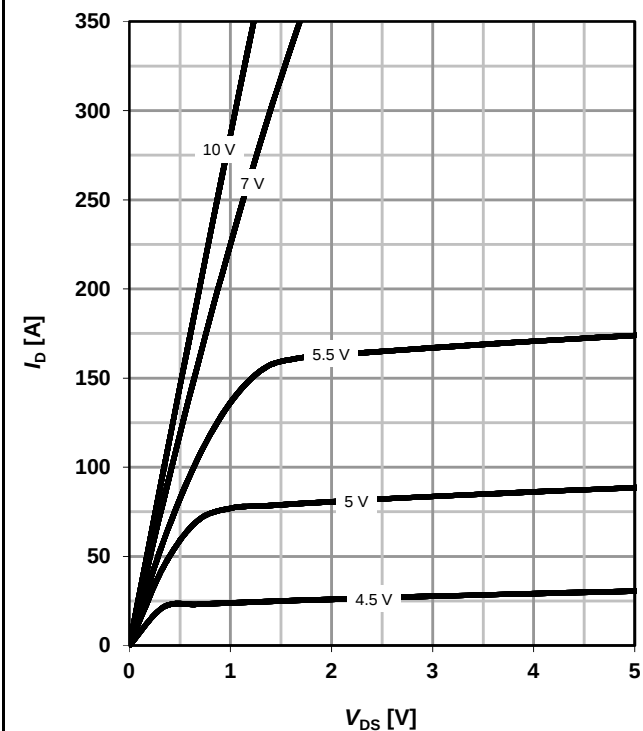
4 Max. transient thermal impedance

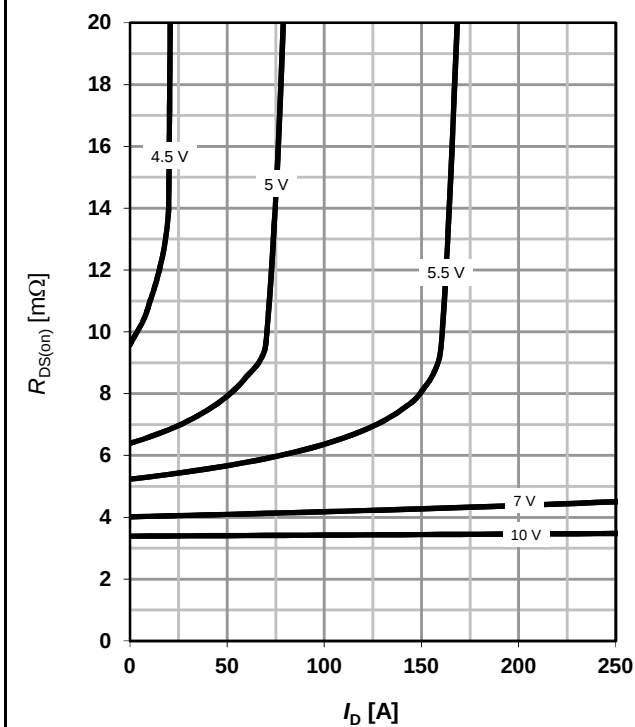

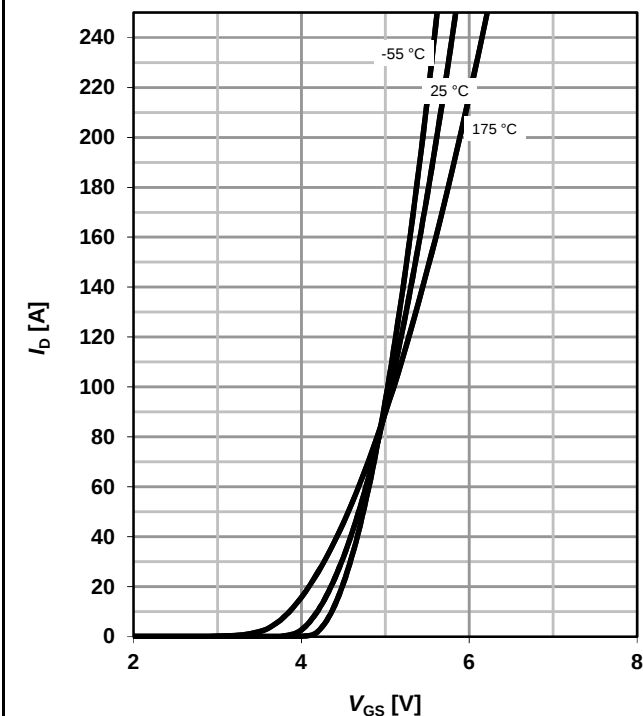

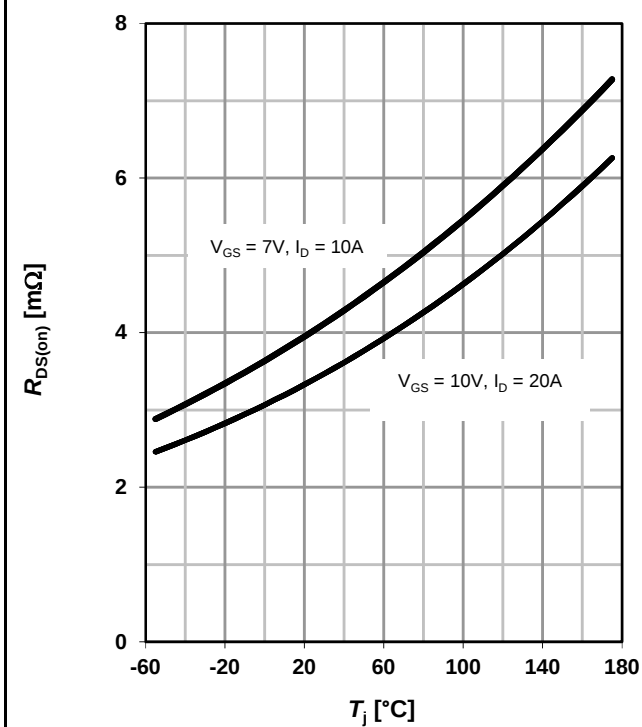

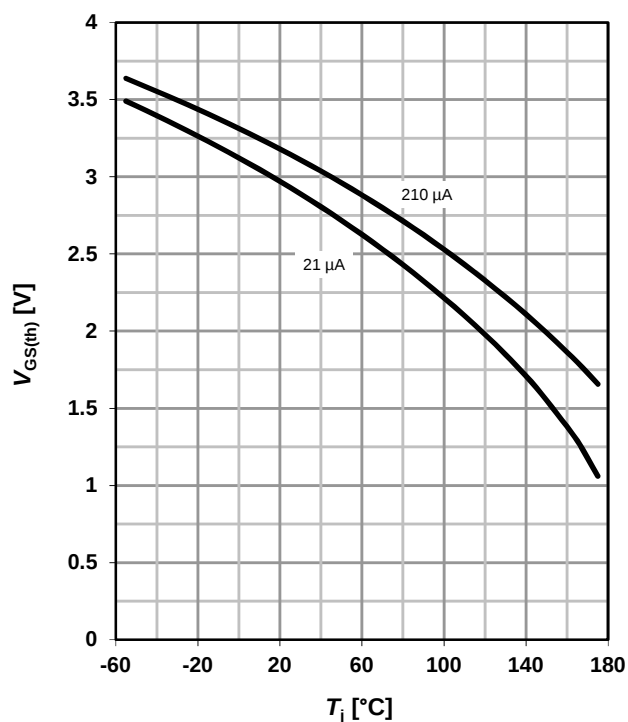

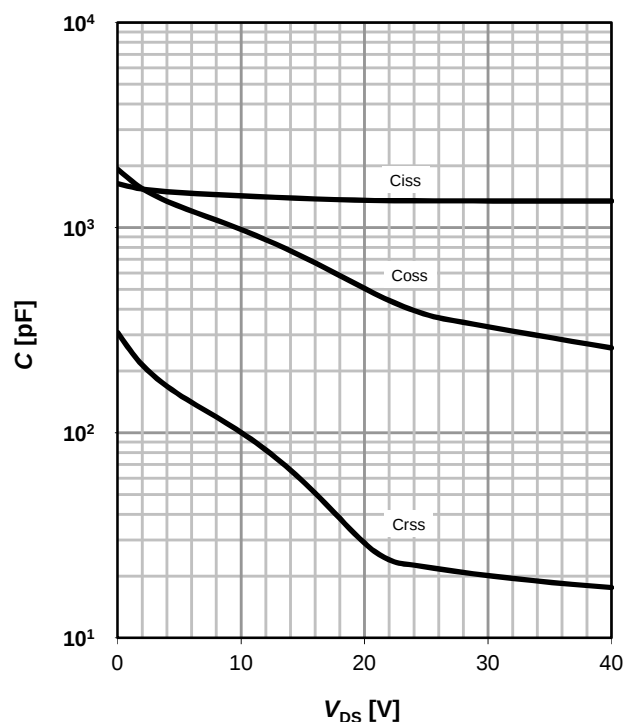

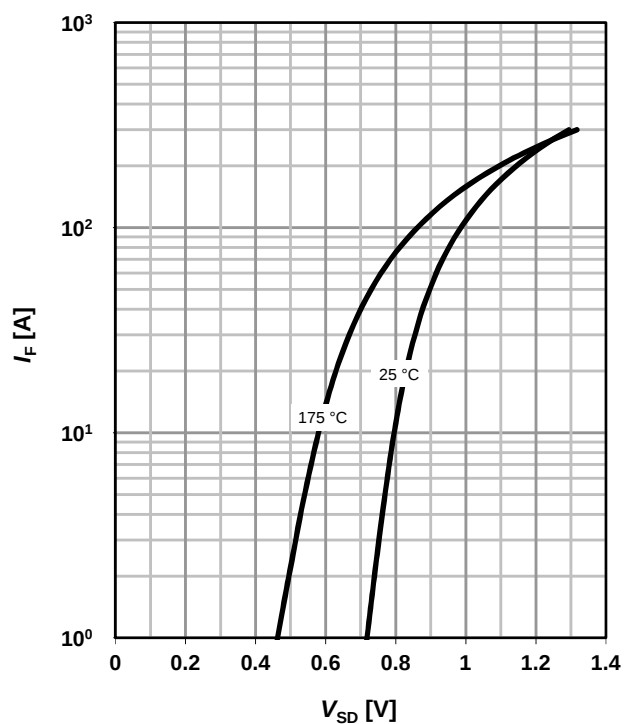

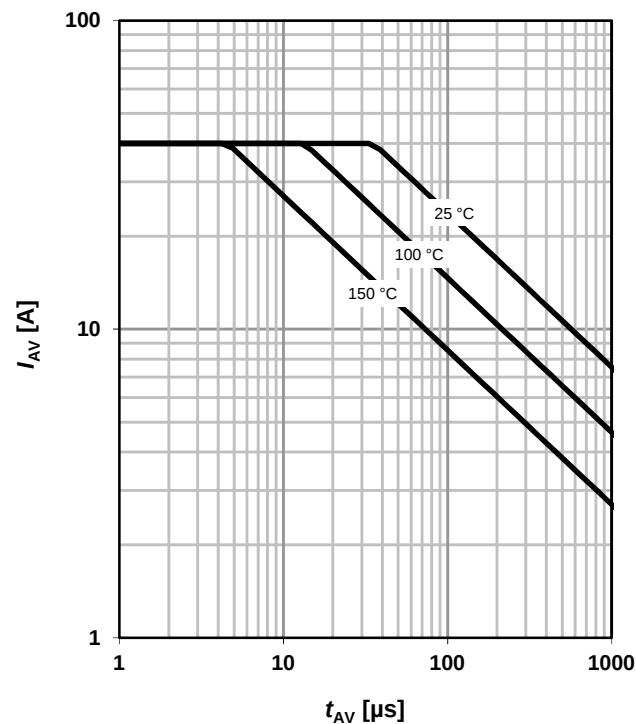

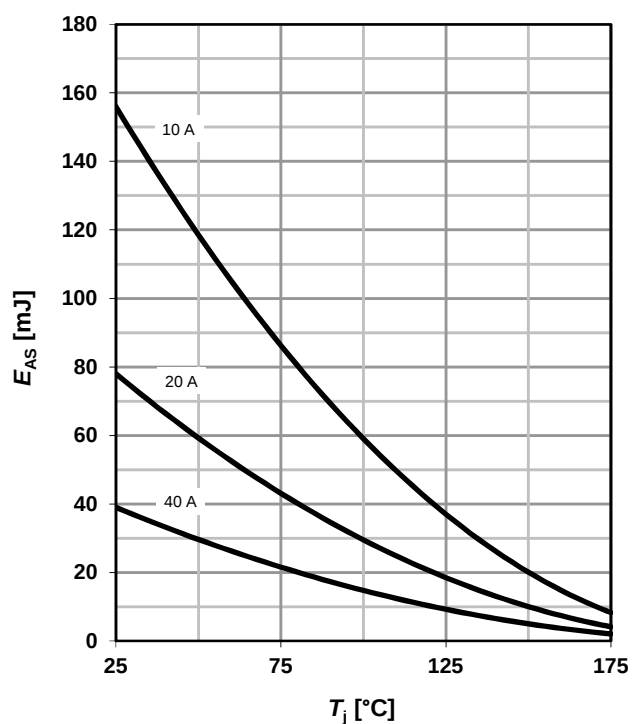

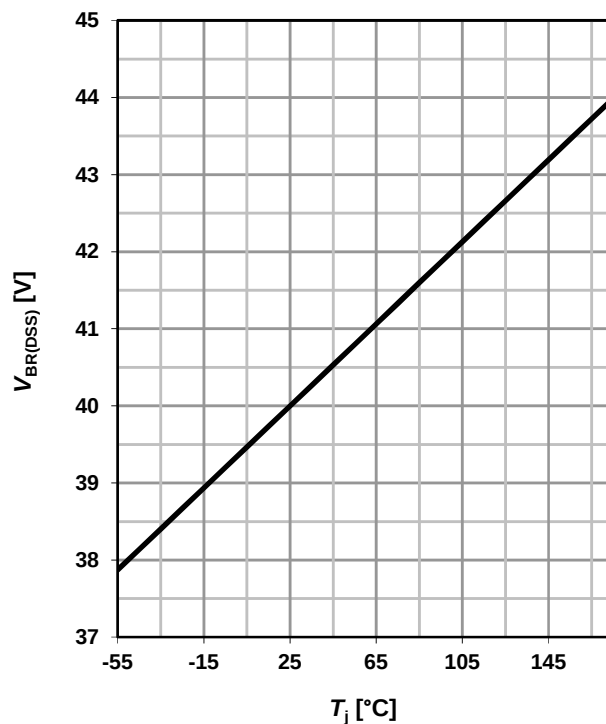
13 Typical avalanche energy

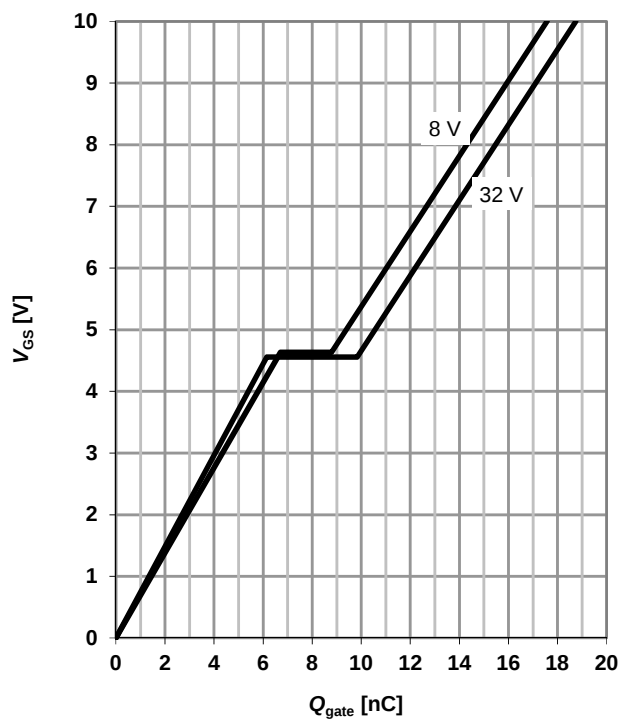
14 Drain-source breakdown voltage

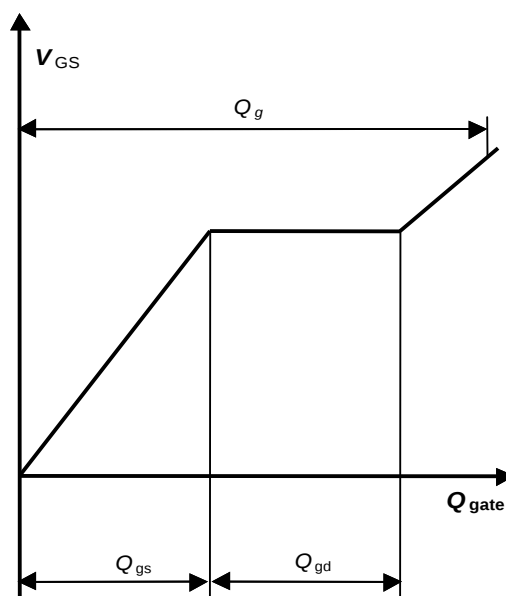

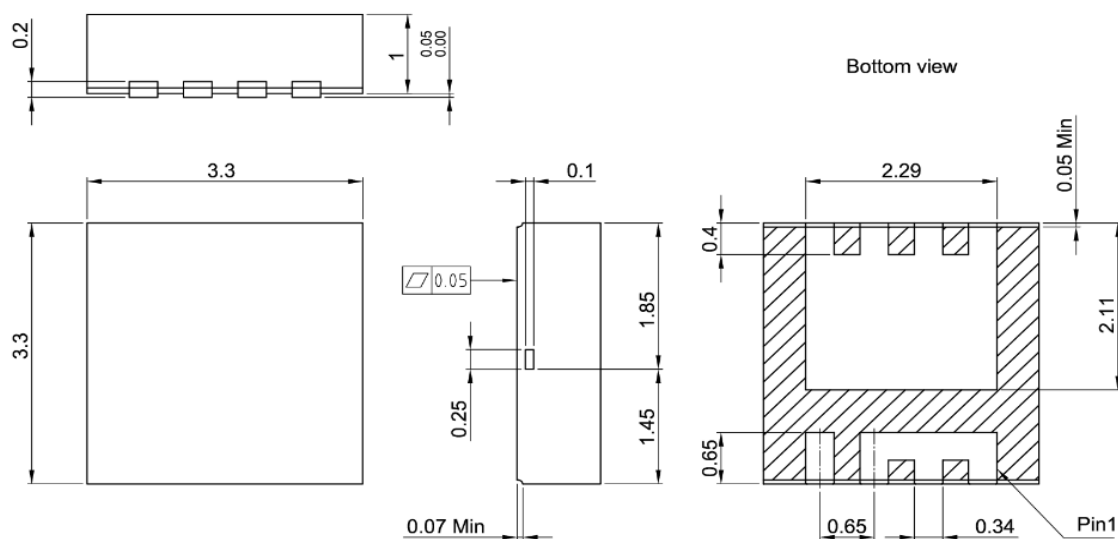

16 Gate charge waveforms

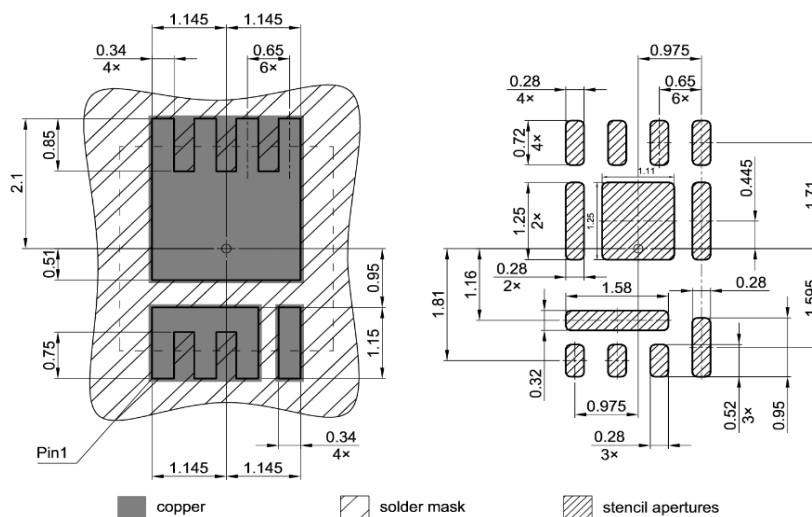

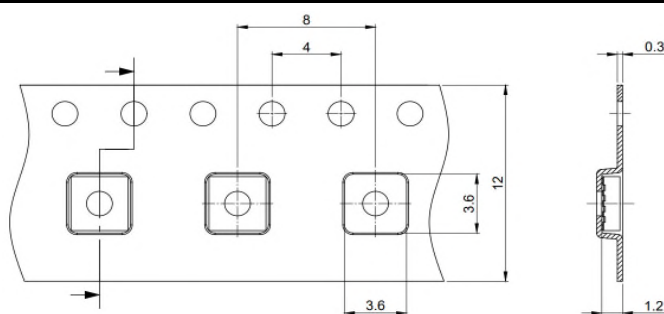
